1. INTRODUCTION

The Leschenault Biosecurity Group Inc (LBG) is a community-run Not-For-Profit group operating in the Shires of Capel, Dardanup, northern half of Donnybrook-Balingup and the City of Bunbury. The LBG offices are in Donnybrook and all operations are coordinated from this site.

The LBG commenced operations in 2014 with a group of committed and dedicated volunteers who managed all programs. In September 2019, the Declared Pest Rate was raised for the first (1st) time across the LBG operational area. The LBG operates with a volunteer Board and 3 x part time staff members.

The LBG takes a positive and proactive approach to facilitating declared pest management and is focused on increasing community awareness on declared pests and their management; and on achieving on-ground outcomes to compliment the great work the majority of individual landholders are already doing.

Our Focus for 2021 – 22 is on the following Declared Pests:

- Apple of Sodom
- Arum Lily
- Bridal Creeper
- Blackberry
- Cape Tulip
- European Fox
- European Rabbit
- Feral Pig
- Narrow-leaf Cotton Bush
- Paterson's Curse.

Whist we state these pests will be the focus of LBG throughout the 2021-22 reporting period, we will respond to requests from landowners/managers to assist with all other pests.



Through our Strategic Plan, LBG has defined its purpose as:

Collaborating with landowners/managers and the broader community to achieve a significant reduction in the impact of pests across our region.

The stated aim of the LBG is to:

Work Collaboratively with Landowners/managers to tackle the increasing spread of pests (both animals and plants) and develop strategies to significantly reduce the impact of these pests on the environment, economy, and landscape.

Growing our successful K5 project:

Increasing landowner/manager uptake by 20% in 2021/22 Continuing to develop community action groups (neighbourhood) to combat rabbits. Whilst developing and facilitating these projects, we will also:

- 1 Develop KPI's to ensure outcomes are measured and reportable
- 2. Provide concise audited financial reports to DPIRD
- 3. Capture all relevant data including:
 - a) Number of engagements (including contact details).
 - b) Details of individuals and community groups engaged with K5 program.
 - c) Mapping and logging of field activities.
- 4. Provide feedback opportunities to participants in all programs as a continuous improvement process.
- 5. Engaging with rate payers and receiving their priorities through
 - i) Social media
 - ii) Community radio
 - iii) Print media
 - iv) Workshops
 - v) Direct contact
 - vi) Newsletter
 - vii) School engagements
- 6. Increase training, resources and educational opportunities for rate payers in pest management.
- 7. Provide timely and accurate information electronically to ratepayers to increase outcomes in pest control.
- 8. Collaboration with Murdoch University, hosting of a PhD Student to conduct research relating to our Declared Pests.
- 9. Collaborate and support other stakeholders with pest management projects.

The value of our programs to the communities we service will be measured in terms of:


- Participation from ratepayers,

Flat rate (Fixed sum):

Leschenault Biosecurity Group recommends that the Minister for Agriculture and Food as per the *Biosecurity and Agricultural Management Act 2007* determines flat rate on freehold land in the City of Bunbury, Shire of Dardanup, Shire of Capel and the northern half of the Shire of Donnybrook Balingup for the financial year commencing 1 July 2021, as follows:

- a) a minimum land size (above one (1) hectare),
- b) a minimum rate payable amount \$45.00 below (10) hectares, \$60.00 above ten (10) hectares.
- c) where land is unrated (less than 1 hectare in size or is crown or leasehold land), the landowner/land manager pays an agreed fee to LBG for services on unrated land.





2. OBJECTIVES

- The objects of the Association are;
 - a To initiate, promote and foster the management of declared pests in the LBG Operational Area, under the requirements of the *BAMAct*.
- 2) The property and income of the Association shall be applied solely towards the promotion of the objects of the Association and no part of that property or income may be paid or otherwise distributed, directly or indirectly, to members, except in good faith in the promotion of those objects.
 - a A payment may be made to a member out of the funds of the Association only if it is authorised under sub-rule b.
 - b. A payment to a member out of the funds of the Association is authorised if:
 - i. the payment is in good faith to the member as reasonable remuneration for any services provided to the Association, or for goods supplied to the Association, in the ordinary course of business; or
 - ii. the payment is of interest, on money borrowed by the Association from the member, at a rate not greater than the cash rate published from time to time by the Reserve Bank of Australia; or
 - iii. the payment is of reasonable rent to the member for premises leased by the member to the Association; or
 - iv. the reimbursement is of reasonable expenses properly incurred by the member on behalf of the Association.



3. BACKGROUND

LBG is led by a Board of volunteer members representing the community. Daily operations are carried out by a small team of part-time staff.
