Instructions for Arum Lily control using a wetting agent: Spreadwet



Instructions for Use of Spreadwet 600 for Arum Lily Control (use no more than 2.5 mls/10 litres water: 2.5mls = 1/2 teaspoon)

- Half fill spray container prior to adding Spreadwet 600 to prevent excessive foaming
- Spreadwet breaks down the surface tension of water droplets (spreader) making the active ingredient carry further & the adjuvant (wetter) allows the product to penetrate the target species.

ACTIVE CONSTITUENT: 600g/l Ethoxylated Nonyl Phenol & Alkyl Ether & Fatty Acid
A wetting agent: NONIONIC SURFACTANT

SAFETY DIRECTIONS: Avoid contact with eyes and skin. DO NOT inhale spray mist. Wash hands after use.

Ingestion: If swallowed do not induce vomiting. Wash mouth with water and give water to drink.

Eye contact: Flush with water to remove any chemical. If irritation occurs and persists, obtain medical attention.

Skin contact: Remove contaminated clothing. Wash skin & flush with copious water.

Inhalation: Remove to fresh air and observe until recovered. Seek medical advice if effects persist.

Advice to Doctor: Treat symptomatically.

Precautions for Safe Handling: Spreadwet 600 is considered Schedule S5 poison. No smoking, eating or drinking should be allowed where material is used or stored. Wear protective equipment to prevent skin and eye contamination. Avoid contact with eyes and skin. DO NOT inhale spray mist. Wash hands after use.

Conditions for safe Storage: Spreadwet 600 is classified as a Dangerous Good: Class C2 (COMBUSTIBLE LIQUID) This product must be stored, transported and sold in accordance with the relevant Health Department regulations. Store in a closed, well-ventilated area away from children, animals, food, feedstuffs, seed and fertilisers. Do not store for prolonged periods in direct sunlight. Do not re-use container for any purpose.

Ecological Information Ecotoxicity: Toxic to aquatic life with long lasting effects.

Disposal: DO NOT dispose of undiluted chemicals on site. Puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of water ways desirable vegetation and tree roots. Empty containers and product should not be burnt.
